Greetings Jeff and Chad,

I'm sure by now you would be expecting an email from me that would not agree with your findings, and yet, I appreciate the email and information you have provided me. However, the last correspondence that Jeff and I had was December 2023. I have been on the Wilmot Township website looking for any indication of this topic to be discussed and was unable to find anything. And now I receive this letter 4 days prior to the Wilmot Township Council meeting that will take place on Monday, May 27, 2024. Thank you for so much notice.

I would like to start off by quoting the words on the bottom of each page of Wilmot Townships Infrastructure Report.

Wilmot is a cohesive, vibrant and welcoming countryside community

Welcoming Countryside Community? I'm not sure how you can put this phrase on each page of a report that is purposing a closure and decommissioning of a bridge that has been in existence for over a hundred years? Oxford Waterloo Road bridge has providing an opportunity for all residents near and far to get from one side of the Nith River to the other.

I feel we would not be in this position if Wilmot Township took matters seriously long before the Ice Jam that caused so much damage to the bridge. Had it been properly repaired and not bandaged over the years, it still might be a viable bridge that so many people enjoy.

It's always about money and it always will be. The Townships only want, "in town' work completed to attract tourism and are not willing to put forth the effort in rural communities that are often forgotten.

Yes you spent millions of dollars to upgrade the bridge on Bridge Street between Tye Road and Puddicombe Road, BUT, on Monday, May 27th, the bridge will be closed yet again for repairs which means we need to put on lots of extra kms one way to access the other side of our own road. I would love you to put a camera just to see how many commuters this will affect and how mad they get when they have to turn around. Plus I would like to know (and sorry if I sound disrespectful) what Engineering company did not understand that water flows down hill? How did they not see that the South side of the bridge was not properly stable to handle any extra water that would flow down. You left me with wishful thinking and I felt you understood the needs of us "limited' residents. I have a few emails between both of these correspondences but I will get to the point.

Josh Brick; Your correspondence to me on May 6th, 2024 said the following:

We recently heard back from Wilmot regarding the OSIM report results.

Based on the repairs/ improvements letter that was provided (including recommendations and associated costs for necessary work) we understand that Wilmot intends to proceed with opening the bridge to pedestrians and light utility vehicles (e.g. ATVs, snowmobiles, etc).

This was good news to me! At least it wasn't full closure so there is hope.

Back to you Jeff Molenhuis;

How do we go from December 2023 to May 6th of hopeful thinking to shutting the door on residents.

I received an email from you on May 23, 2024 and you included a report that Wilmot Staff will be recommending a FULL CLOSURE AND DECOMMISSIONING of Oxford Waterloo Road Bridge 37B-OXF. This report was published in the K-W record and was put on the agenda for the Wilmot Township Council Meeting on Monday, May 27th, 2024. No communication was given to residents.

I attended the May 27th Wilmot Township Council meeting and I know for a fact that Wilmot Township Counsellors did NOT endorse the Full Closure and Decommissioning of OW bridge.

June 3rd, 2024, I have now been notified that Blandford-Blenheim Township will be presenting the recommendation of Full closure of OW 37B-OXF on June 5th.

I'm asking this question:

How is it that Wilmot Township staff still presents Option #1-Full Closure to Blandford-Blenheim when Wilmot Counsellors did NOT endorse this? I feel Wilmot Township should be advising Blandford-Blenheim of the updated report that includes 'Wilmot Counsellors' did NOT endorse Full Closure/Decommission.

This should not be about money but transparency as to what is happening within our Townships. I now know, without attending regular Council meetings, residents have no idea what is happening.

	We received communication from a neighbor regarding the future of the Oxford-Waterloo Rd. bridge. The report from staff to Wilmot Council suggested that resident input was requested.
	Resident numbers are small because this is a farming area, so there are few houses. However, I hope this will not affect the decision. I would hope we have the same rights of being heard regardless of how many we are.
John & Andrea Black	We are a family of seven We would like the bridge opened to vehicle traffic. Here are our concerns.
	COMMUTE My husband commutes to Stratford twice a day. When the bridge was open, he would head west on Oxford-Waterloo across the bridge and then continue north and west to work. Now, he has to go east to Puddicombe then back west across bridge. This inconvenience costs our family time and money.
	LOST JOBS Our teens used to milk goats at a barn . It is located at the far west end of Oxford-Waterloo Rd. Since our teens were too young to drive, we would take them to and from work. Once the bridge closed down, the driving distance increased by

approximately 16 kms per milking shift as we would have to go around a "country block" four times - there and back for drop off and there and back for pick up.

Due to the unreasonable amount of driving for a teen job, they had to quit working there, which was both a disappointment and a loss of income at a good employer.

LEFT TURN ONTO PUDDICOMBE

The left (north) turn onto Puddicombe from the west side of Oxford-Waterloo Rd. is tricky at the best of times. The road is 80 km/h, which means most people are traveling 90-100 km/h. There is a large curve as you come up Puddicombe from the south, plus a downhill drop from the north.

To compound matters, there are usually either crops growing in the southwest field or the ditch grass is uncut. Currently, the grass is over 2 ft tall and seriously obscures driving sightlines.

At our request, Blandford-Blenheim erected signs warning of a hidden intersection, but the turn is still dangerous.

For these reasons, we used to avoid the intersection as much as possible. Now, we are forced to use it all the time. These stressful turns are not helpful for our teens who are just learning how to drive.

UNUSUAL ACTIVITY AT THE RIVER

While we have no way to confirm what is occurring at the bridge, we strongly suspect the area is used by those engaged in illegal activities, such as selling drugs.

As I am at home most days, I am able to observe the traffic patterns. I have noticed several high-end vehicles driving up and down Oxford-Waterloo Rd. There is very little to attract them to our area - no parks, no scenic views, no mansions where they might have friends to visit. Furthermore, people in sports cars very rarely like driving on gravel roads for fear of stone chips.

Logically speaking, we should only be seeing farm vehicles and the cars and trucks of local residents, of whom there are few. Why, then, are there Audis and Mercedes on our road? This situation is beginning to make us very uneasy. We know that neighbors have contacted the police about this, but the police cannot be present 24/7.

LOSS OF SENSE OF COMMUNITY

We have five children under 18. When we moved here in 2020, I was quite comfortable allowing them to bicycle down to the bridge and ride on the path along the river which a neighbor has cleared for public use.

Now, I do not want them down there on their own. What if they stumble across a drug deal? Are their lives then in danger? Because I don't know the answer to this, I live with some fear.
