




## **Where to Focus**

#### **Buildings and Transportation make up 93.6% of the GHG emissions**




## This was Wilmot's <u>Projected</u> 50 x 30 path from 2010 to 2030 for Natural Gas

> 1200-2400 residential units\*



# What can Wilmot Council do about the problem?

Our specific ask to council:

Direct staff to prepare a report within 3 months that provides options & recommendations for actions that the Township can take to:

- Make substantial reductions in natural gas consumption
  in Township operations.
- Incentivize or require substantial reductions in natural gas consumption
  in new construction.
- Encourage and assist residents and businesses to make reductions in natural gas consumption in existing buildings.



What does NVEB plan to do about the problem?

In partnership with the Township:

Provide educational events to homeowners describing the problem and presenting options for decreasing natural gas consumption including:

Switching from <u>natural gas</u> furnaces, water heaters and stoves to <u>electric</u> heat pumps, water heaters and stoves.

Applying for grants and interest free loans from government programs to purchase heat pumps and heat pump water heaters.
