

**THE CORPORATION OF THE TOWNSHIP OF WILMOT**

**BY-LAW NO. 2025-35**

**BEING A BY-LAW TO AUTHORIZE THE MAYOR AND CLERK TO SIGN THE  
APPROPRIATE LAND TRANSFER DOCUMENTS TO RECEIVE A SEGMENT OF OXFORD  
ROAD 5 FROM THE CORPORATION OF THE COUNTY OF OXFORD AND UPLOAD THE  
BOUNDARY SHARE OF OXFORD ROAD 5 TO THE REGIONAL MUNICIPALITY OF  
WATERLOO**

**WHEREAS** Subsection 5(3) of the Municipal Act, 2001, S.O. 2001, c.25, as amended, provides that a municipal power shall be exercised by by-law;

**AND WHEREAS** the Corporation of the Township of Wilmot, the Corporation of the County of Oxford, the Corporation of the County of Perth, and the Regional Municipality of Waterloo all share jurisdictional interests as road authorities in the intersection known as “Punkeydoodles Corners”;

**AND WHEREAS** at its meeting held on December 11, 2023, the Council of the Corporation of the Township of Wilmot passed a resolution endorsing a recommendation to proceed with intersection improvements at Punkeydoodles Corners, and further requested that the upper-tier municipality, being the Regional Municipality of Waterloo assume ownership of the Corporation of the Township of Wilmot’s portion of Oxford Road 5 within the Punkeydoodle’s Corners area;

**AND WHEREAS** it has been identified that the Corporation of the County of Oxford also owns a portion of Oxford Road 5 within the Punkeydoodle’s Corners area;

**AND WHEREAS** the Regional Municipality of Waterloo has agreed to assuming ownership of both the Corporation of the Township of Wilmot and the Corporation of the County of Oxford’s respective portions of Oxford Road 5;

**AND WHEREAS** the Regional Municipality of Waterloo has requested that the transfer of both portions of Oxford Road 5 to the Regional Municipality of Waterloo be facilitated in a single consolidated transfer from the Corporation of the Township of Wilmot, in accordance with Section 52 of the *Municipal Act, 2001*, S.O. 2001, c.25 which provides that an upper-tier municipality may add a lower-tier highway to its highway system;

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF WILMOT ENACTS AS FOLLOWS:**

1. That the Mayor and the Clerk are hereby authorized to execute under seal all land transfer documents and papers relating the receipt of ownership of the Corporation of the County of Oxford's share of Oxford Road 5 to the Corporation of the Township of Wilmot.
2. That the Mayor and the Clerk are hereby authorized to execute under seal all land transfer documents and papers relating to the uploading of the ownership of the boundary share of Oxford Road 5 to the Regional Municipality of Waterloo.

**READ** a first and second time in Open Council this 23<sup>rd</sup> day of June, 2025.

**READ** a third time and finally passed in Open Council this 23<sup>rd</sup> day of June, 2025.
