RE: Proposed Aggregate Extraction at 1894-1922 Witmer Road, Wilmot

This letter is intended to demonstrate my concerns regarding the aggregate operation noted above. As a member of the community that will be negatively impacted by this undertaking I would like to identify my concerns.

I am opposed to the Hallman Pit for the following reasons:

- I am concerned that aggregate extraction and related activities (permit to draw water, wash ponds, asphalt and concrete recycling) will inevitably affect the quality and quantity of my water as this pit lies in a regional recharge area and a wellhead protected area according to the Source (Water) Protection Plan.
- I am concerned about environmental issues related to the wetland and woodland on the property and surrounding. I am concerned about the rehabilitation plan and question the loss of prime agricultural land.
- I am concerned about the safety risks related to the haul route on a township road (with limited line of sight, no shoulders, guard rails, hidden driveways, school bus route) and connected regional roads along with dangerous intersections.
- I do not feel that the home owners will be properly compensated for their loss of property value and quality of life and safety because of the operation of such a gravel pit in close proximity to a long-standing community. I am concerned that Wilmot residents' taxes will have to cover road repairs and lost value in property.

Thank you for taking the time to address these concerns as I consider this a serious threat to our community and our lifestyles.

Re: IBI Response Letter (03/09/21) to Representative of CSGW's Objection to Jackson Harvest Farms Application

Although I may not be an official objector under the ARA process, I wish to make my objection known with regards to the Jackson Harvest Farms application for an aggregate licence at 1894 - 1922 Witmer Road, Wilmot, ON.

The response letter from IBI group to representatives of CSGW (Citizens for Safe Ground Water) does not satisfy my objection to the proposed Hallman pit and I see the following items as outstanding:

- * Removal of sand and gravel increases the vulnerability of the groundwater and it is my opinion that this is unacceptable so close to municipal wells and private well owners
- * I feel the proposed auxiliary uses such as wash ponds and asphalt and concrete repurposing and stockpiling pose an unnecessary and unacceptable risk to the quality and quantity of our water
- * We remain concerned about the rehabilitation plan and question the possible loss of prime agricultural land as outlined in Michael K. Hoffman of AgPlan Limited review.
- * The amended planning report with cumulative impacts by IBI Group must be peer reviewed by the various experts to ensure cumulative impacts are addressed fully to protect the community.
- * Safety of residents, cyclists, motorists and recreational road users along the haul route and at the intersection of Queen Street and Witmer Road have not been adequately addressed.
- * The noise impacts to the community of Shingletown and residents of Witmer Road have not been adequately identified or addressed as described in review by J. E. Coulter Associates Ltd. AND the air quality impacts to the community of Shingletown and residents on Witmer Road have not been adequately identified or addressed. An air quality assessment report has not been completed. We believe that this must be done to comply with the PPS and requirements for a zone change.

I feel there is no need for a new license in this area. There are a long list of pits already licensed in the area. Some are currently operating and some are not yet operating. I am not aware that any have been rehabilitated. The operating pits serve the needs of repurposing materials.

Furthermore, the cumulative impact of the Hallman pit, on top of all the pits already licensed in this area, is unacceptable to impose on any community in Ontario.

Thank you for taking the time to address these concerns as I consider this a serious threat to Shingletown, Witmer Road, Wilmot Township and other rural communities in Ontario.
