The land being considered for the donation has been shared by the owners for the enjoyment of community members for decades. The extensive trail network has been used for hiking, cross country skiing and bird watching. The land is important ecologically as it is the home of many plant and animal species. In addition, as part of the Laurel Creek Headwaters, this property has been designated as an Environmentally Sensitive Landscape.

The Nith Valley EcoBoosters' mission statement indicates our commitment to achieving and supporting a long-term healthy environment in our community. Advocating for the protection of natural spaces is key to reaching that goal. A healthy environment is necessary for the well-being of all life on our planet. For these reasons we are absolutely in favour of this donation of land.
